Identity number _____ agree to the following:

1. The welfare of the animals and birds in the care of FreeMe will at all times be regarded as the first priority.
2. FreeMe's aim is the full rehabilitation of cases. All behaviour and actions of volunteers will assist in achieving this objective. Volunteers will co-operate in ensuring that imprinting is kept to a minimum and accept that euthanasia will be performed if deemed necessary by Vets/Director/Manager.
3. Monthly volunteer meetings will be attended as far as possible.
4. Members of the public are not permitted in the clinic or aviaries without permission from the Director or Manager
5. Volunteers are not permitted to make press releases or deal with any officials on behalf of FreeMe unless specifically authorised to do so.
6. Volunteers agree to purchase and wear the official FreeMe uniform when on duty.
7. All fund raising efforts need to be cleared with the Director/Manager.
8. All cases rehabilitated at home are treated under the FreeMe permit and protocol. Volunteers will immediately return all such cases to FreeMe upon request by the Director/Manager.
9. Volunteers acknowledge that all cases are treated under the FreeMe permit and undertake to acquaint themselves with the provisions of such permit and to ensure that they do not in any way breach the conditions of such permit.
10. Volunteers acknowledge that they are dealing with wild animals that are by nature unpredictable and may be dangerous. By signature hereof, I indemnify FreeMe against any claim in respect of injury to myself or family or invitees and/or damage to property incurred while carrying out my duty as a volunteer.
11. Volunteers are advised and agree to have regular anti- tetanus inoculations and other inoculations or medical treatment as may be deemed advisable at any time at their own expense.
12. Volunteers agree to abide by the Constitution of FreeMe and the instructions of the Director/Manager.
